**PC-33-09 MA – Petition for Change of Zone / Map Amendment OR-68-09 –**

A petition for change of zone / map amendment has been submitted by Ronnie Strouse requesting to rezone property located at 9643 Alward Road (Parcel ID#19-140-024-100-016-60), Section 24, Victor Township, from A-2 – General Agriculture District to A-3 – Agricultural / Residential Transition District.
