DEWITT PUBLIC SCHOOLS BONDING PROPOSAL

Shall DeWitt Public Schools, Clinton County, Michigan, borrow the sum of not to exceed Ten Million Four Hundred Thirty Thousand Dollars (\$10,430,000) and issue its general obligation unlimited tax bonds therefor, for purposes of:

constructing, furnishing and equipping additions to and remodeling, furnishing and refurbishing and equipping and re-equipping school facilities; acquiring and installing educational technology improvements to school buildings; constructing, furnishing and equipping a new team room building at the High School athletic stadium; developing, improving, equipping and re-equipping athletic facilities and play fields; and developing and improving school facility sites?

The following is for informational purposes only:

The estimated millage that will be levied for the proposed bonds in 2010, under current law, is 0 mill (\$0.00 on each \$1,000 of taxable valuation). The maximum number of years the bonds may be outstanding, exclusive of any refunding, is twenty-five (25) years. The estimated simple average annual millage anticipated to be required to retire this bond debt is 1.08 mills (\$1.08 on each \$1,000 of taxable valuation).

If the school district borrows from the State to pay debt service on the bonds, the school district may be required to continue to levy mills beyond the term of the bonds to repay the State.

(Pursuant to State law, expenditure of bond proceeds must be audited, and the proceeds cannot be used for repair or maintenance costs, teacher, administrator or employee salaries, or other operating expenses.)

VICTOR TOWNSHIP PROPOSAL:

MILLAGE PROPOSITION TO RENEW THE ONE AND ONE-HALF (1.5) MILL LEVY FOR FIRE PROTECTION SERVICES AND EQUIPMENT

Shall the previously voted increase in the fifteen (15) mill tax limitation imposed under Article IX, Section 6 of the Michigan Constitution on general ad valorem taxes within Victor Township be renewed and levied at one and one-half (1.5) mills (\$1.50 per \$1,000.00 of taxable value) for a period of four (4) years from 2010 to 2013, both inclusive, for the purpose of defraying, in whole or in part, the cost of fire protection services and equipment, which levy includes restoration of millage lost (.0426 mills) as a result of the reduction required by the Michigan Constitution of 1963, and shall the Township levy such increase in millage for said purpose, thereby raising, in the first year, an estimated \$177,753.00?
