## **A RESOLUTION RE-ESTABLISHING THE CLINTON COUNTY COMMUNITY CORRECTIONS BOARD AND AUTHORIZING THE BOARD TO MAKE A COMMUNITY CORRECTIONS GRANT APPLICATION**

**WHEREAS**, in December 2013 the Clinton County Board of Commissioners elected not to renew the grant application for Community Corrections, and the Clinton Community Corrections Advisory Board, formed under Public Act 511 of 1988, was disbanded; and

**WHEREAS**, the Clinton County Prosecutor's office, the 29<sup>th</sup> Circuit Court, and Clinton County Sheriff's Office have jointly requested the Board to Re-establish the Community Corrections Advisory Board under Public Act 511 of 1988 so that Clinton County could seek alternative sanctions funding for its felony population; and

**WHEREAS**, the Clinton County Board of Commissioners recognizes the need for meaningful alternatives to felony incarceration, and that alternative sanctions are expected to be linked both to prison diversion and improved utilization of the Clinton County Jail; and

**WHEREAS**, in order to renew a grant application for Community Corrections grant funds under the guidelines established by the Michigan Department of Corrections Office of Community Corrections, this would necessitate authorizing appointment to the Clinton County Community Corrections Advisory Board; and

**THEREFORE, BE IT ADVISED**, that the Clinton County Board of Commissioners hereby re-establishes the Clinton County Community Corrections Advisory Board.

**BE IT FURTHER ADVISED THAT**, the Clinton County Board of Commissioners authorizes the posting of its intent to appoint members to the Clinton County Community Corrections Board consistent with Public Act of 1988, specifically MCL 791.407;

**BE IT FURTHER ADVISED** that the Clinton County Board of Commissioners supports the submission of an application to the Michigan Department of Corrections for State Corrections Act Funds for the remainder of Fiscal year 2014.
