## **RESOLUTION 2015-7**

### **ADOPTING AMENDMENTS TO SOLID WASTE MANAGEMENT PLAN**

At a regular meeting of the Board of Commissioners of the County of Clinton, Michigan, held at the County Building in St. Johns, Michigan on the 26th day of May, 2015, at 9:00 o'clock a.m. local time.

WHEREAS, Part 115 of Michigan's Solid Waste Management Act (MCL §324.11501 et seq.) ("Part 115") requires Clinton County to promulgate and periodically amend a Solid Waste Management Plan ("Plan");

WHEREAS, Clinton County has adopted such a Plan and its Solid Waste Planning Committee has presented this Resolution as a Plan amendment for Board Approval

WHEREAS, the Clinton County Board of Commissioners determines that approval of the Plan amendment incorporated in this Resolution is in the best interests of the County's citizens;

NOW, THEREFORE, BE IT RESOLVED that the following amendment to the Clinton County Solid Waste Management Plan of 2000 are hereby approved:
